Further to our letter dated February 14, 2017, we wish to inform you that World Resorts Limited (WRL) vide its letter dated March 07, 2017 have informed the Company that in their Board Meeting held on March 02, 2017, the Board has approved the variation in terms of 50,00,000, 10% Cumulative Redeemable Preference Shares of WRL allotted to Industrial Investment Trust Limited.

The revised terms of the Preference Shares are as under:


1. Coupon Rate has been reduced from 10% to Zero percent w.e.f. April 01, 2016.
2. Nomenclature has been changed from 10% Cumulative Redeemable Preference Shares to Zero percent Redeemable Preference Shares.
3. The period of redemption of Preference Shares shall be extended for a period not exceeding 17 years from the date of issue of Preference Shares. The details of which are tabled hereunder:
