1. Introduction

iv. Notification: You will be notified via email regarding the status of your refund request. If approved, the refund will be processed back to the original payment method.

v. Intimation of Failed Payment: In case of failure in payment by the Company, an intimation will be sent by an e-mail.

5. Liability in Specific Cases

The company shall not have any liability if it is unable to affect any Payment Instruction(s) on the Payment Date owing to any one or more of the following circumstances:

- a. If the Payment Instruction(s) issued by the customer is incomplete, inaccurate, and invalid and delayed.
- b. If the Payment Account has insufficient balance for the amount as mentioned in the Payment Instruction(s).
- c. If the existing funds in the Payment Account are under any encumbrance or charge.

d. If your Bank refuses/delays honoring the Payment Instruction(s).

e. Circumstances beyond the control of Company (including, but not limited to, fire, flood, natural disasters, bank strikes, power failure, systems failure like computer or telephone lines breakdown due to an unforeseeable cause or interference from an outside force).
